## MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

University "Ukshin Hoti" Prizren, (Republic of Kosova), legally represented by his Rector,

Prof.assoc.dr. Ismet Temaj, resident for this appointment

In Prizren 20000, Republic of Kosova

AND

University of Camerino, UNICAM, (Italy), legally represented by his Rector,

Prof. Claudio Pettinari, resident for this appointment

In Camerino, Piazza Cavour n. 19/f.

This agreement is based on the principle of reciprocity and expresses the interest of both parties in exchanging scholars, researchers, students, academic information, and materials in the belief that the establishment of such exchange programs will increase the research and educational process quality.

- Parties agree to encourage the development of the following exchange programs based on their respective academic, research, and educational needs:
  - Exchange of faculty and researchers
  - Exchange of students (undergraduate, graduate, PhD)
  - Traineeships and student visits
  - Exchange of academic information and materials
  - Organization of joint degree programs
  - Organization of joint research programs
  - Organization of joint conferences
  - Organization of other academic exchanges agreeable to both universities
- Parties recognize that the implementation of any exchange will depend upon the research and academic interests and expertise of individual faculty members and researchers and upon the availability of financial resources. Accordingly, the implementation of each exchange program based on this agreement shall be separately negotiated and determined by both parties.

3. Cooperation terms for each activity implemented under this MOU shall be agreed upon by both Parties in writing, prior to the initiation of that activity. Any such supplementary agreement will form an integral part of this MOU.
  
4. This Memorandum does not impose on the Parties any financial or property obligations. It is meant to describe the nature and to suggest the guidelines of the cooperation described above. Therefore, nothing shall diminish the full autonomy of the institutions, nor will any constraints be imposed upon the others in carrying out the agreement.
  
5. The agreement shall become effective on the day representatives of both parties sign this agreement, and will be in force for a period of 5 years. The agreement is subject to revision or modification by mutual agreement, It is also understood that each institution may terminate the agreement at any time, although it is assumed that such action would be taken after consultation in order to avoid any possible inconvenience to the other institutions.

For UUHP, Prof. ass.dr. Shemsi Morina and for UNICAM prof. Emanuele Tondi shall serve as liaison officers for this agreement.
