COOPERATION AGREEMENT FOR THE ORGANIZATION OF THE INTERNATIONAL SUMMER SCHOOL

BETWEEN

University "Ukshin Hoti" Prizren

&

International Documentary and Short Film Festival "DokuFest"

&

Innovation and Training Park (ITP) Prizren

Article 1

The Cooperation Agreement (hereinafter referred to as the Agreement) is concluded between the University "Ukshin Hoti" Prizren, represented by the Acting Rector Prof. Assoc. Dr. Samedin Krrabaj, DokuFest, represented by Executive Director Linda Llulla, Innovation and Training Park (ITP) Prizren (managed by the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH), represented by Authorized Representative Muhamed Rexhepi.

Article 2

The purpose of this Cooperation Agreement is the cooperation between three (3) parties for the organization of the International Summer School at the University "Ukshin Hoti" Prizren.

Article 3

University "Ukshin Hoti" Prizren, DokuFest and ITP Prizren agree to assist, promote, support and enhance mutual cooperation between the parties, in order to organize the International Summer School.

Article 4

University "Ukshin Hoti" Prizren, DokuFest and ITP Prizren together will contribute to the organization and progress of the International Summer School, including joint activities as follows:

- 1. Courses/modules of the International Summer School;
- 2. Extracurricular activities:
- 3. Artistic, cultural and sports activities;
- 4. Round tables:

- 5. Thematic workshops;
- 6. Professional seminars;
- 7. Open lectures with invited personalities;
- 8. Joint promotion of the International Summer School; and
- 9. Other activities of the mutual interest.

Article 5

University "Ukshin Hoti" Prizren, DokuFest and ITP Prizren agree on a joint application in the preparation of proposals for joint national and international projects related to the support and progress of the International Summer School.

Article 6

DokuFest will accept a number of students of the University "Ukshin Hoti" Prizren to perform professional practice in the premises of DokuFest during the period of festival.

Article 7

ITP Prizren agrees to provide accommodation for a number of students (up to 60 students) in dormitories within ITP Prizren. for the needs of the International Summer School.

Article 8

University "Ukshin Hoti" Prizren, DokuFest and ITP Prizren agree to exchange experts and their experiences in certain fields for the needs of the International Summer School.

Article 9

University "Ukshin Hoti" Prizren, DokuFest and ITP Prizren agree on the use of infrastructure, classrooms, amphitheaters, etc. for the needs of the International Summer School.

Article 10

The cooperation agreement is valid for a period of five (5) years, with the possibility of extension, completion or change with the mutual consent of the parties.

Article 11

The cooperation agreement is signed in three (3) copies in Albanian and three (3) copies in English. In case of discrepancy, a copy in the Albanian language shall prevail.

This agreement enters into force on the day of signing by the signatory parties.
