Memorandum of Understanding

Between

The Polish Legal Clinics Foundation – Poland

And

University "Ukshin Hoti" of Prizren - Kosovo

The Polish Legal Clinics Foundation, henceforth Foundation, represented by the President,
Dr. Filip Czernicki - in Warszawa, Poland, ul. Szpitalna 5 lok. 5, 00-031

AND

University "Ukshin Hoti" of Prizren – Kosovo, henceforth UPZ, represented by Rector
Prof. Asoc. Dr. Samedin Krrabaj, residing in "Rruga e Shkronjave" no.1 Prizren 20000 Kosovo,

Faculty of Law of University "Ukshin Hoti" Prizren – Kosovo, represented by Dean, 9
Prof. Asoc. Dr. Muharrem Faiku, residing in "Rruga e Shkronjave" no.1 Prizren 20000 Kosovo,

(hereinafter named THE PARTIES)

Considering that both parties acknowledge the importance of establishing relations between higher education institutions and organizations belonging to different countries, in order to achieve their institutional aims

Considering that they have areas of common interest and similar, promoting the work of legal clinics have decided to establish the following Memorandum of Understanding (hereinafter referred to as MOU).

Article 1

The Parties agree to exchange information, experience and relevant documents on strengthening of Legal Clinics of the Faculty of Law at UPZ.

Among other things, the parties will cooperate in the

- design and implementation of international projects,
- organizing and participation in international conferences,
- strengthening the legal clinics of the Faculty of Law, etc.

Other cooperation opportunities can be jointly agreed upon by the Parties in the future.

Article 2

For the implementation of activities among those outlined above, the Parties hereby agree to draw up a separate agreement and to implement the project and activity within the framework of the rules and regulations of both Parties, and subject to availability of funds and resources of each.

Article 3

The Parties agree to designate, on behalf of each institution, a coordinator whose responsibility will be to supervise the execution of this MOU:

At UPZ, this coordinator will be Muharrem Faiku – Dean of Law Faculty

At Foundation, this coordinator will be Dr. Filip Czernicki.

Article 4

This MOU will not give rise to any financial obligation by one Party to the other. The Parties acknowledge that in the absence of any specific agreement in writing to the contrary, each Party will be responsible for its own costs and expenses in establishing and conducting projects and activities contemplated under this MOU.

Article 5

This MOU shall take effect after it has been signed by both parties on the last date of signature and shall continue to be effective for a period of five (5) years, renewable automatically for an identical period, if neither party notifies in writing the other of a desire to terminate the Agreement at least six (6) months prior to the concluding date.

The provisions of this MOU in respect of any on-going exchange programme or any other form of cooperative activity under this MOU shall continue to apply until their completion, unless both Parties mutually agree in writing to the earlier termination of the programme or activity.

Article 6

This MOU is written in duplicate copies in English with each of the copies being equally authentic, signed by their duly authorized representatives.

Each Party will be responsible for any fiscal charge related to the execution of this MOU, according to the rules and regulations applicable in each institution.
