I. Conditions and documentation for application

1. Documentation for application :

- Application and CV,
 - Copy of the relevant diploma (for the position of teacher, diploma of three levels of studies; while for the position of assistant diploma of two levels of study and the grades certificate) notarized;
 - Birth extract (original) and copy of the identity card;
 - Criminal record from the court (original);
 - Candidates who are employed in any institution of higher education in the Republic of Kosovo must also present the decision for the last choice as well as the report on the performance evaluation (if applicable).
 - Evidence for scientific and professional publications, as well as other specific additional information, which is important for those who apply;
 - Proof of knowledge of English or any other language/ preference.
2. Candidates who have received a doctorate, master's degree or who have completed a master's degree abroad must also bring proof of certification of the relevant degree by MEST, otherwise the applicant's file will be considered incomplete.

II. Deadline and method of application

1. The deadline for application according to this competition is from 7.6.2023 to 22.6.2023 at 16:00.
2. The presentation of the documents is done in the relevant academic units by submitting the physical copy as well as scanned on CD; the same in electronic copy is also sent to the official e-mail: apliko.upz@uni-prizren.com.
3. Applications received after the deadline and those that are incomplete or irregular will not be accepted (will not be reviewed by the relevant committee).
